Comcast Spectacor: As EVP and CFO for this Philadelphia-based American sports and entertainment company, Gary prioritized operational excellence through the development of new systems, processes and investments in technology, content, and infrastructure, resulting in 15% growth in revenue and 171% growth in cash flow. For the Spectra hospitality division, he successfully helped grow Venue Management, Food Services and Ticketing revenue by 19%, and Spectra's Operating Cash Flow by 89% in four years.

Comcast Business Services: As SVP Finance and CFO for this division of Comcast that handles sales, marketing, and delivery of internet, phone, and cable television to businesses, Gary was one of the founding members of the leadership team who grew the business at a meteoric pace and achieved a run rate of more than \$4 billion in revenue, \$1.6 billion in cash flow, and more than 1 million customer relationships during his tenure.
