## Key Experience

**National Restaurant Chain:** As Interim CFO for this \$120 million national restaurant chain recently acquired by a new private equity sponsor, Jeff served as Interim CFO where he implemented strategies to improve cross-functional communication to provide clarity on the company's cash position from which forecasted requirements were recommended and executed. This resulted in the creation of a robust 13-week cash forecast model with built-in variance analysis, negotiation with vendors to expand terms to improve liquidity, and successful renegotiation of financial covenants with the senior lender.

**SaaS Company:** As interim Controller Jeff managed the complete overhaul of the accounting function for this \$500 million company. This included the application of revenue recognition and cash/receivables to validate all accounts and guide the company through the annual audit process to resolve prior significant deficiencies.

**Wholesale Beverage Distributor:** As Controller and Interim CFO for this \$200 million retail and wholesale beverage distributor, Jeff oversaw multiple store openings along with the rapid expansion of the wholesale division. Company growth expanded from 30 to over 70 locations, and revenues increased from \$120 to \$218 million. Jeff supervised the audit process, tax return preparation, bank relationship management, financial reporting, forecasting cash flows, and operating income. He also managed accounting and finance departments with a total of 25 direct reports. Jeff assisted in the acquisition of an alcoholic beverages retailer, which added 32 retail locations and over \$100 million in revenues. He also coordinated all regulatory licensing, renewals, and compliance through the Texas Alcoholic Beverage Commission. Jeff played an integral role in the sale of the company to a private investor group.
